11. **Restrictions:** You may not modify our trademarks, logos, or other intellectual property in any way. You may not use our intellectual property in any manner that disparages us or our products/services.

You agree to keep all information related to our affiliate program confidential, including commission rates, business strategies, and any other proprietary information shared with you. This obligation will survive the termination of this Agreement.

### **Limitation of Liability**

To the maximum extent permitted by law, we will not be liable for any indirect, incidental, special, or consequential damages, including loss of profits, even if we have been advised of the possibility of such damages. Our total liability to you for any cause of action arising out of or related to this Agreement will not exceed the total amount of commissions paid or payable to you under this Agreement.
